Position Description:

The primary responsibility of the LGBTQ-Youth Advocate is to initiate, organize, plan, develop, and implement direct advocacy services to assigned clients and their families. All service plans will be based on a strength-based approach using the wrap around model.

Summary:

Our mission is to engage human service systems so that they understand the needs of the LGBTQ community; particularly those of teenagers. Our goal is to invest more in supporting families and community resources to better connect and serve this population. We currently work with child welfare, juvenile justice, behavioral health, disability, primary health care, and education systems to develop and offer community-based alternatives for the highest risk children, young people, young adults and families, and adults. Applicant must be dependable, committed, and able to serve as a positive role model for youth in the LGBTQ community, school and home settings.

Qualifications/Requirements:

- Bachelor's Degree (Masters preferred). Computer knowledge is preferred.
- Pass Criminal and Child Abuse Clearances.
- Position requires access to reliable transportation, valid driver's license, and car insurance limits of \$100,000/\$300,000 bodily injury liability.
- This position requires background checks to be completed annually

This position offers flexible hours, competitive weekly pay and activity reimbursement.

It's important to use this exact same acronym in the cover letter/resume. They have included the "Q" for the queer community, so you should also include the Q in all of your documents.

Pay close attention to these 5 verbs. Use these verbs or synonyms in your resume and cover letter to directly relate your skills with the job description.

While these two methods may be foreign to you, take the initiative to introduce other methods that you may have experience with to demonstrate your flexibility/adaptability

This is a great opportunity to demonstrate your skills in working with teams, or recruiting, and/or presentation skills.

This is a wide variety of social services which involve multiple cohorts of people. Try to connect your experiences with as many of these as you can to indicate your specific skillset.

Again, highlight your related experiences to match the specific populations mentioned here.

These are all considered soft skills. It won't be enough to show your completion of your degree with these skills. You will need to elaborate and prove you possess these soft skills.

Be sure to highlight your computer/software/programming skills in your resume. Just because something seems simple to you, it may not be to someone else. An example would be to list Microsoft Office (Word, Excel, PPT).

This most likely means that you will need to use your personal vehicle for business travel. Make sure to ask questions about this in your interview to see if you will be reimbursed for gas or other travel expenses.
